After some discussion, it was agreed that this decision was needed in order to acknowledge the extraordinary effort being made by staff in building up a new school and also to assist in the recruitment and retention of highly skilled teachers. As the sibling rule was included to facilitate the logistical demands on existing parents, this decision extends such access to another cohort of our existing school community.
