1. Minutes of the previous meeting

2. Introduction to Schoology (David)

- Parental access possible via parents' codes given by David

Q&As

Can parents access marked tests?

- Depending – only if this is a digital test. The details can be visible after clicking on the link to the test in the “Grades” tab

There is a great variety of resources for each subject: how can we help students to be more organized?

- David could advise textbooks for his subject
- David is developing e-book for geography, other teachers may join this initiative
- Students are encouraged to download the materials into folders onto e.g. memory sticks or a personal computer to keep them more organized

How long is the exposure to screens and iPads at school?

- Depending on subjects but, in general, iPads are used sporadically and their use is discouraged at breaks

Schoology used for too much of the assessment. How can we ensure that students do develop also traditional skills of e.g. hand-written tests, essays?

- Most tests are done on paper
- Students often have a choice to complete their homework in their copies

Where is Schoology hosted? How about Data Protection? Who owns the data?

- David will find out re hosting
- Wriggle has a very detailed policy on Data Protection and is willing to share it

How do we regulate Schoology use and overuse?

- Some rules regarding the use will need to be established e.g. teachers should not post on Sundays (unless in emergency)
- The deadline for 12 midnight is set as a default option – this can be changed but it is debatable if this will solve a problem of students sitting up late at night to finish assignments

4. AOB

- Extra-curricular activities – parents ask for sufficient notice (e.g. 10-14 days) and consultation whenever financial costs are involved
- Payments for extra-curricular activities and voluntary contribution may be enabled via Schoology online
- Transport issues – ET must lobby at the State level – what can parents do? They could send letters to lobby free transport for ET schools.

ACTION POINTS:

- David will find out where Schoology is hosted and whatever protection is given to the users
- David (TBC) will set up some basic rules/schools' policy regarding Schoology use
- David will prepare a FAQ sheet for parents regarding Schoology; parents to e-mail questions to (Jon?, David?)

- Reaching out – a survey to be sent out to parents (? TBC)
- Academic/Community Interest – an email to be sent out to parents to reach out
- Transport issues – Jon to contact other PCs in ET secondary schools to survey whether an unified lobbying action is possible
